

Dear River Dell Community:

This letter is to provide detailed information regarding COVID cases in River Dell and what to expect as we enter the holiday break. All statistics are as of the closing of school today.

- Seventy-two (72%) percent of students are fully vaccinated.
- Ninety-four (94%) of staff are fully vaccinated.
- Between September 1 and December 16, there were fifteen (15) positive cases in students. Six (6) of those cases occurred in the middle school and nine (9) in the high school. During the same period, there were seven (7) cases in staff.
- Between December 17 and today, there were twenty-five (25) positive cases in students. Fifteen (15) of those cases occurred in the middle school and ten (10) in the high school. During the same period, there were two (2) cases in staff.
- There are 1603 students enrolled in the district. The infection rate within the population is 2.5%.
- There are 247 employees in the district. The infection rate within the population is 3.6%.

While the infection rates are extremely low, it is foolish to ignore the recent increase in cases. This suggests that there is community spread within the boroughs we serve. We will continue to work with local and state health officials to monitor the situation during the holiday break. Our goal is to keep school open, but we must be prepared for every possibility including a return to virtual instruction. The decision to implement remote learning is not made unilaterally by the Board of Education or the Superintendent. Below is an excerpt from the latest communication form the Bergen County Executive County Superintendent of Schools:

Districts must consult their local health department to determine if a closure is necessary due to COVID-19 outbreaks. Prior to closing any school building(s) due to COVID-19, LEAs must first consult with the local health department to determine if building closure is the most appropriate response to the circumstances in a given school building.

The decision to move a school to remote learning is not a decision the Superintendent or Board can make alone. That decision needs to come from the department of health.

River Dell will follow this advice and communicate any changes in local conditions during the holiday break. We anticipate reopening on January 3, 2022.

We know there will be cases of COVID over the break. We ask that you refer to the following charts for guidance on the required quarantine and date your child is permitted to return to school. Please remember that vaccinated students do not need to quarantine after close contact if they remain asymptomatic.
