







There are teacher tech trainers and opportunities for teachers to enlarge their teaching repertoires. Additionally, a focus on inclusion and diversity has been a focus as staff attended guest speaker sessions in this area.



Student Supports and Services:

Students with disabilities have access to study skills as well as classrooms with in-class support. Each teacher is available to tutor students and several student honor societies provide one to one tutoring during lunch as well as after school. RDHS is an inclusive environment with a Transition Program for students. An active I&RS committee works to assist struggling students.



Physical Education classes offer a modern approach to fitness and students may select from a variety of activities. Students are exposed to health education throughout their time here and seniors are taught CPR. Additionally, all junior students are trained in Teen Mental Health First Aid during their health class. In addition, an assortment of counseling services are available for students that support social/emotional wellbeing. The district holds an annual Health and Wellness Fair in September and also now offers Wellness Wednesday programming for students and families alike.
